Children's Worlds is a research survey on children's subjective well-being conducted across many populations worldwide was conducted in Appalachia Kentucky. Descriptive indicators of children's well-being across multiple dimensions (material well-being, health, family well-being, school satisfaction, safety, peer relationship quality, etc.) were collected and analyzed to understand general levels of children's well-being.

EatMoveGrow: Innovating Health in Rural Schools
