### Top rural and community hospitals announced

The National Rural Health Association (NRHA) has announced the 20 highest-ranked prospective payment system (PPS) hospitals in the country based on an evaluation by the Chartis Center for Rural Health. The hospitals are identified using the Chartis Rural Hospital Performance INDEX, the most comprehensive and objective assessment of rural PPS hospital performance. These hospitals will be recognized May 18 during [NRHA's Rural Hospital Innovation Summit](#) in San Diego, Calif.

The determining factors for the top 20 rural and community hospitals are based on eight indices: inpatient market share, outpatient market share, quality, outcomes, patient perspective, cost, charge, and financial efficiency.

“NRHA is committed to ensuring our members have the best information to manage their hospitals,” says NRHA chief operations officer Brock Slabach. “We’re pleased to recognize the accomplishments of these rural and community hospitals.”
